



E-bike Giveaway

Official Rules & Regulations

1. Eligibility:

This giveaway is open only to those who fill out the giveaway form and who are 18 years of age as of the date of entry. Employees of the Fraser Valley Conservancy, its affiliates, subsidiaries, board of directors, and contractors, (collectively the “Employees” and the immediate family members and/or those living in the same household of Employees are not eligible to participate in the Giveaway. The Giveaway is subject to all applicable federal, provincial, and local laws and regulations, and is void where prohibited.

2. Agreement to Rules

By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and eligibility requirements. In addition, You agree to accept the decisions of the Fraser Valley Conservancy as final and binding as it relates to the content of this Giveaway.

3. Giveaway Period

Entries will be accepted online during the period of July 15, 2023 at 12:00 a.m. PST and ending on September 30, 2023 at 11:59 p.m. PST.

4. How to Enter

The Giveaway must be entered by submitting an entry using the online registration form provided through the Fraser Valley Conservancy website. The entry must fulfill all Giveaway requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of the Fraser Valley Conservancy.

The Winner of the Giveaway (the “Winner”) will receive the advertised prize. The specifics of the prize shall be solely determined by the Fraser Valley Conservancy. No substitution of the prize or transfer/assignment of the prize to others is permitted. Acceptance of prize constitutes permission to use Winner’s name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law. **THE WINNER MUST BE ABLE TO PICK UP THE BIKE FROM THE FRASER VALLEY CONSERVANCY OFFICE IN ABBOTSFORD, BC WITHIN ONE MONTH OF BEING SELECTED.**

6. Odds

The odds of winning depend on the number of eligible entries received.

7. Winner Selection and Notification

Winner will be selected by a random drawing using an online contest application, under the supervision of the Fraser Valley Conservancy. Winner will be notified by phone and email within 5 days following the selection of Winner. Fraser Valley Conservancy shall have no liability for Winner’s failure to receive notices due to spam, junk e-mail or other security settings or for Winner’s provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within 7 days from the time the award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternative Winner selected ...

The Fraser Valley Conservancy reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Giveaway should virus, bug, non-authorized human intervention, fraud, or other cause beyond the Fraser Valley Conservancy's control corrupt or affect the administration, security, fairness, or proper conduct of the Giveaway. In such case, the Fraser Valley Conservancy may select the Winner from all eligible entries received prior to and/or after (if appropriate) the action taken by the Fraser Valley Conservancy. The Fraser Valley Conservancy reserves the right, in its sole discretion, to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Giveaway or website or violates these Terms & Conditions. The Fraser Valley Conservancy has the right, in its sole discretion, to maintain the integrity of the Giveaway, to void votes for any reason, including, but not limited to: multiple entries from the same user from different IP addresses; multiple entries from the same computer in excess of that allowed by Giveaway rules; or the use of bots, macros, scripts, or other technical means for entering.
